1. FSM & Easter:

The DfE have updated their Free Schools Meals guidance regarding Easter provision: https://www.gov.uk/government/publications/covid-19-free-school-meals-guidance-for-schools

An additional FAQ about Easter holidays makes it clear that schools should continue to provide FSM over this period for those children who are out of school. The National Voucher Scheme will now run over this time and schools will be compensated by central government for any other arrangements they have made to provide for these children; up to the value of £15 per eligible pupil.

2. School Funding:

New guidance from the DfE has been published setting out the financial support they will put in place for all schools. Overall Funding

The DfE has been clear that in terms of usual school funding:

- Schools will continue to receive their core funding allocations; regardless of any periods of
 partial or complete closure (to ensure schools can continue to pay staff and meet other
 regular financial commitments);
- LAs will also continue to receive their high needs budgets and should continue to pay top-up and other high needs funding to schools (to ensure that the employment and payment of staff supporting pupils with SEND can continue);
- Where schools pay top-up or other funding for pupils attending alternative provision, or pay
 for other SEND or AP services, it is expected these payments continue (to ensure that
 teachers and other staff can be paid in accordance with their existing employment contracts)



Exceptional Funding

The DfE has recognised that there will be changes to what schools need to fund at this time. They are asking schools to continue to manage their budgets in the most effective way possible, and to redirect existing resources to best support all their pupils, particularly vulnerable children and children of critical workers. This includes using any additional funding which schools are anticipating adding to their reserves in the 2020/21 financial year.

However, where schools incur additional costs as a result of COVID-19, the DfE will make funding available where schools are not able to use their existing resources. The DfE has outlined the areas it would be expecting to support:

- Increased premises related costs associated with keeping schools open during the Easter and/or summer half term holidays;
- Support for FSM for eligible children not attending school associated with costs arising before the introduction of the national voucher scheme and costs of providing meals directly where schools are not using this scheme;
- additional cleaning associated with requirements following confirmed or suspected coronavirus (COVID-19) cases, in line with <u>COVID-19</u>: <u>cleaning of non-healthcare settings</u> guidance

Where schools face other extraordinary costs to deliver appropriate support to their pupils through this period outside this list and they cannot be met by existing budgets, they should contact DfE.CoronavirusHelpline@education.gov.uk.

The DfE have also set a limit on funding allowances for exceptional expenditure as follows (please note pupil numbers will be taken from the October 2019 census):

Mainstream schools	
250 pupils or fewer	£25,000
251 to 500 pupils	£30,000
501 to 1000 pupils	£50,000
Over 1000 pupils	£75,000

Special schools and alternative provision	
All schools	£50,000

Claiming financial support

The DfE will publish further guidance for schools on the process for informing them of any additional costs relating to COVID-19 in June 2020.

Until then, schools are asked to make the necessary payments from existing budgets and record these in line with local finance policies.

3. Educational Resources:
